




Busan International Financial District with Extensive Financial and Business Facilities

Busan is the second largest city in Korea. Its deep harbor and gentle tides have allowed it to grow into the largest container handling port in the country and the fifth largest in the world. The city's natural endowments and rich history have resulted in Busan building a reputation as a world class city of tourism and culture, and also becoming renowned as an international convention destination.

Location

Located at the southeastern tip of Korean Peninsula, Busan has served as Korea's gateway to the world since its opening as an international port in 1876. As a critical link between the Pacific and the Eurasian Continent, Busan also has become a major logistics hub, ranked as the world's 5th largest container port.

GFCI Ranking

On March, 2014, the City of Busan announced that it was selected as one of the new entrants into the Global Financial Centres Index (GFCI) published by the Z/Yen Group which ranks the competitiveness of financial centers.

Although entering the index for the first time, Busan was ranked 27th, ahead of leading financial cities such as Dubai (29th), Osaka (34th) and Paris (36th). Additionally, the city was ranked 2nd in the category of "ten centers likely to become more significant in the next few years," followed by Singapore (3rd), Hong Kong (4th), and Seoul (7th).





Busan,

City Environment

Busan, a city of beautiful mountains, rivers and the sea, is also an important cultural city. With the Nakdong River bordering the city and superb natural scenery like Haeundae adding nationwide attraction, the city serves as a major nexus of cultural activities around the region. Also, Busan is the first international port city in Korea. Its location enables the city to serve as a main gateway for the Korean peninsula and the entire northeast Asian region.



Location



Geographically, Busan has the Straits of Korea to its south; Ulsan to the north; Gimhae to the west. Cities that share almost the same latitude with Busan include Jinhae and Gwangju in Korea, as well as Tokyo, Algiers and Oklahoma City abroad. Busan is nine hours ahead of GMT. As for its geopolitical location, the city comes at the southern tip of a strip that connects Asia, Siberia and Europe. It also serves as a main gateway to the Pacific Ocean. This location places the city at the center of international sea transportation.

Climate

Busan is located at the southeasternmost tip of the Korean peninsula and in the mid-latitude temperate zone, which has seasonal winds. It has four seasons : spring, summer, fall and winter. The annual average temperature is 14.9°C. The annual average precipitation is 1,441.9mm. Busan is breezy compared to other areas in Korea. Spring begins in March and ends in late June. Cherry blossom trees bloom in late March, and the temperature is very comfortable in April, May and June. The rainy season at the end of June and July signals the beginning of the summer heat. The highest mean temperatures of around 32°C are observed at the end of July through mid-August. Fall is from early September through late-November. The weather is nice and cool at this time because of the continental high atmospheric pressure. Winter starts by the end of November and continues until February, but Busan rarely has any snowfalls. The average winter temperature is 3.8°C. Tourists can enjoy Busan throughout all seasons because of the nice weather and beautiful scenery. In summer, the city is crowded with visitors who come to enjoy the beautiful beaches.



Population

From its opening in 1876, the port city of Busan quickly developed into a hub of trade, commerce and industry. This development resulted in a rapid increase in its population, which had already reached 200,000 by 1936. Busan's population continuously rose since then, surpassing 1 million by the end of 1955. The key factor that spurred the population increase was the government policy for economic growth. People from urban areas kept streaming into the city for jobs. By the end of 1994, there were approximately 4 million people who called Busan their home. Since 1995, the population has slowly begun to decrease. As of December 2013, Busan was home to 3,563,578 people.

Transportation System



Busan is a gateway city connecting the Eurasian continent with the ocean, and is at the same time a logistics hub of Northeast Asia, located on the world's busiest sea routes. Various transportation systems - by air, sea, and land - have now been expanded and developed to a top-notch standard.

Busan city has successfully hosted major international events such as the 2002 Korea/Japan FIFA World Cup, the 2002 Busan Asian Games and the 2005 APEC Economic Leaders' Meeting. Notably, the ITS World Congress, known as the 'Olympics of Transportation,' was held in Busan in 2010. Through the successful hosting of these and many other events over the last ten years, the city has created a high-tech transportation system and an advanced transportation culture.

Public Transportation

There are 4 subway lines in Busan, extending 108.7kms in total length. It serves as a convenient local public transportation system.



Metropolitan Transportation

Busan has been trying to establish a broader metropolitan transportation network by building or expanding railways and expressways, including the double-track construction of the Donghae-Nambu railway line (Bujeon, Busan ~ Ulsan, 65.7km), the Bujeon-Masan Double Track Electric Railway (Bujeon Station ~ Jinrae, Gimhae, 32.6km) and the Busan ~ Gimhae Light Rail (Sasang Station, Busan ~ Samgae-dong, Gimhae, 23.8km), new expressways (Busan ~ Ulsan, Busan ~ Eonyang, Busan ~ Daegu), and a coastal highway.

Air Transportation

There is a growing number of international flights at Gimhae International Airport, which currently handles 472 international flights a week to and from 28 cities in 10 countries.



Marine Transportation

There are 4 ferry routes to Japan (Shimonoseki, Fukuoka, Tsushima and Osaka)

Gyeongbu High Speed Rail (Seoul-Busan Line)

The second stage of the Gyeongbu High Speed Rail network, the Daegu-Busan KTX line (124.2 km) was completed in 2010. The travel time between Seoul and Busan takes only 2 hour and 10 minutes.

Major global corporations based in Busan include Renault Samsung Motors (automobiles), Rolls Royce (R&D), Fraunhofer (R&D), Kongsberg Maritimes (marine equipment), Bosch Korea (machinery), LME (warehouse), DWI (port logistics), PSA (port logistics), and Mitsui (port logistics). The majority of foreign invested companies operating in Busan are in distribution & logistics (23%), and manufacturing (41%).


Fun and Interesting Tours Organized All Year Round
